Fiscal Note

This proposed resolution approves plan documents for the South Park Street pavement repair project at a total estimated cost of \$2,850,000. In the adopted 2019 capital budget \$1,650,000 GO Borrowing was authorized in 2019 for the first phase of construction on the stretch of Park Street starting at Badger Road to the railroad tracks. Awarding of any project contract will be contingent on common council approval of a subsequent resolution amending the adopted 2019 capital budget for a transfer of \$1,200,000 GO Borrowing within Engineering Major Streets capital budget to cover the updated cost estimate of the project.

Body PREAMBLE

The project will consist of concrete repairs on only the northbound lanes of South Park Street from West Badger Road to the railroad crossing and from West Olin Avenue to West Washington Avenue.
