Fiscal Note

The proposed resolution authorizes an amendment to an existing contract for design services (contract 8412) for the amount of \$12,539. The new contract as amended will total \$237,539.. Existing funding is authorized for the increased contract cost within the adopted 2019 capital budget via the Citywide Flood Mitigation program which provides appropriated \$7,570,000 in GO Borrowing and Stormwater Utility reserves in 2019 (MUNIS 11513).
