- 2. That the sidewalk improvements **and bituminous surface pavement** on the following streets be and are hereby accepted:
  - Arbor Mist Pass from W Line of Lot 192 to Sugar Maple Lane
  - Shady Birch Trail from W Line of Lot 205 to Sugar Maple Lane
  - Silicon Prairie Parkway from Sugar Maple Lane to E Line of Lot 38
  - Sugar Maple Lane from N Line of Lot 33 to South Plat Limit
