That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A" \$16,298.70.

- 4. That the street improvements, **including the bituminous pavement**, on the following streets be and are hereby accepted:
  - · Di Loreto Avenue from 508 Ft. E of Portage Rd to 787 Ft. E of Portage Rd

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 11512 \$44,055.00 for a useful life of 40 years.
