The proposed resolution approves plan documents for Annual Horizontal Sawcutting of Concrete Sidewalk and Incidental Work (Districts 4 and 8) - 2020. The estimated cost of this work is \$56,000. The sawcutting program provides for the horizontal sawcutting of trip hazards in Districts 4 and 8 and throughout the City to comply with ADA guidelines. The sawcuts are funded solely by the City.
