#### Fiscal Note

The proposed resolution authorizes awarding Public Works Contract 8543 for the Rimrock Interceptor - Industrial Drive Extension at a total cost of \$836,150 including contingency. The City has entered into an agreement with the City of Monona (RES-16-00612) to pay 70% of the project costs. Legislative File 59718, introduced on 3/3/20 and adopted by the Finance Committee on 3/9/20, would increase the Municipal Capital Participation funding by \$130,000 to fully accommodate the City of Monona’s share of project costs. Sufficient budget authority for the City’s share of the proposed contract is available in MUNIS account 11446-83-200. No additional City appropriation is required.
