Fiscal Note

The annualized cost of the proposed amendment is approximately \$3,400, including benefits. The Planning Division's second quarter projection has an overall projected deficit of approximately \$67,000, primarily due to a salary and benefits projected deficit of approximately \$121,000. The Planning Division will likely need a 2020 operating budget amendment to cover the projected salary and benefits deficit in FY 2020, notwithstanding the proposed recreation of position #624.
