Fiscal Note

The proposed resolution allows for an agreement with Dane County to provide Metro Transit access to Dane County employees. Dane County will reimburse Metro based on actual ridership and effective rates at the time the ride is taken. Fixed route is currently at \$1.35 per trip and paratransit is at \$3.25 per ride. Metro Transit unlimited ride pass revenues are projected to include \$15,000 from this arrangement in 2020 and \$25,000 as part of the 2021 budget.

WHEREAS, the Parties have negotiated a contract to meet their on-going needs;

NOW THEREFORE BE IT RESOLVED that the Mayor and the City Clerk are authorized to enter into a three-year contract that will automatically renew for an additional two years under the same terms and conditions (if not amended or terminated by either Party) with Dane County for all fixed route and paratransit trips taken by Dane County employees during the term of the agreement.
