### Fiscal Note

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for Annual Horizontal Sawcutting of Concrete Sidewalk and Incidental Work for Districts 13 and 14 at a total estimated cost of \$211,000. ### Body

PREAMBLE

The sawcutting program provides for the horizontal sawcutting of trip hazards in Districts 13 and 14 and throughout the City to comply with ADA guidelines. The sawcuts are funded solely by the City.
