### Fiscal Note

As stated in the Employee Agreement between the City of Madison and Krishna Kumar, the Water Utility General Manager's initial year's salary will be based on a total annualized rate of \$150,000 effective June 1, 2021. The Water Utility's adopted 2021 operating budget includes sufficient funding for the cost of the position. Annual salary adjustments may be made during the term of agreement at the Mayor's discretion, subject to Common Council approval.
