Fiscal Note

The proposed resolution authorizes an amendment to the contract with MSA Professionals, Inc. for design services for Atwood Avenue Reconstruction. The contract was originally authorized under RES-16-00375. No additional appropriation is required.

Title

Authorizing the Mayor and the City Clerk to execute an Amendment to the contract between Madison and MSA Professionals, Inc. for time extension for the Atwood Ave. Reconstruction Project. (6th &15th ADs) **Body**

The City is proposing to reconstruct Atwood Ave. from Fair Oaks Ave. to Cottage Grove Rd. The City entered into an agreement with MSA Professionals, Inc. for design services (Original: RES-16-000375). Geometry was approved for the project by Common Council (RES-18-00533). City Engineering & City Traffic Engineering were authorized to proceed with final design for reconstruction of the street.

The exact construction year is unknown at this time and the City is currently exploring options for federal grant funding for this project. The City Engineer recommends that the contract with MSA Professionals, Inc. be extended through the end of 2023.

NOW THEREFORE BE IT RESOLVED that the Mayor and City Clerk are hereby authorized to execute an Amendment to the contract between Madison and MSA Professionals, Inc. for time extension for the Atwood Ave. Reconstruction Project.
