Fiscal Note

The proposed resolution requests exemption from the Dane County Library tax levied under Section 43.57(3) and 43.64(2) Wisconsin Statutes. All libraries within Dane County have collectively adopted service standards to ensure access to library services across Dane County municipalities. Adhering to these standards allows localities to submit a request for exemption from the Dane County Library Tax levied by the Dane County Board. The value of this exemption is approximately \$12,054,082.
