The proposed resolution authorizes an amendment to the existing contract for engineering services for the total amount of \$99,870. The new contract as amended will total \$264,393. \$99,870 is provided in the 2021 Adopted Stormwater Utility Operating Budget to support Citywide Flood Mitigation and flood reduction analysis (MUNIS 12846-84-200-84000). No additional appropriation is required.

PREAMBLE

The City of Madison Engineering Division is proposing to conduct watershed and flood studies as a result of extreme rain events over the past several years. The City entered into an agreement with Tetra Tech, Inc. for engineering services related to flooding evaluation in the East Isthmus and Yahara River watershed (RES-20-00352). The City Engineer requested additional engineering services and recommend that they be undertaken by Tetra Tech, Inc. for the East Isthmus and Yahara River Watershed Study as defined below:

- 1. Build an existing conditions model for the Isthmus Central watershed
- 2. Evaluate flood mitigation alternatives for the Isthmus Central watershed
- 3. Complete a watershed study report for the Isthmus Central watershed
