Fiscal Note

The proposed resolution approves the use of Safe Routes Grants funding for installation of new sidewalk on Dean Avenue and Allis Avenue at a total estimated cost of \$94,500. The Safe Routes Grants program pays 50% of a property owner's sidewalk assessment where new sidewalk is installed on eligible projects. Funding for this program is from GO borrowing. The 2021 Capital Budget for Engineering-Bicycle and Pedestrian has \$100,000 budgeted for the Safe Routes Grants program (MUNIS 11112).
