**Fiscal Note**

The proposed resolution authorizes up to \$3,788.50 for a façade improvement grant. This grant will be funded by the Economic Development Division’s Small Business Equity and Recovery Program. No additional City appropriation is required.

**Title**

Authorizing the City’s Façade Improvement Grant to 319 State Street, LLC for a project located at 319 State Street. (4th AD)

**Body**

WHEREAS, on October 3, 2000, the Common Council adopted Resolution ID # 61179, approving the Facade Improvement Grant Program to support and encourage small local businesses to reinvest in the downtown and smaller, neighborhood shopping and business areas and designating the Community Development Authority as the agent of the City for the operation and administration of the Program; and

WHEREAS, the grants are matching grants and will be provided in an amount up to 50% of the total project costs up to a maximum of \$10,000 for a single facade, \$20,000 for a building with two facades, and \$25,000 for a “flatiron” building; and

WHEREAS, the Facade Improvement Grant Program Staff Team has reviewed the proposal from 319 State Street, LLC and determined that it meets the requirements of the Program; and

WHEREAS, the Urban Design Commission reviewed the proposal and made an advisory recommendation that the door have full view glass, and that the applicant either reuse the existing hardware or find hardware more in keeping with the commercial style of the building.

NOW, THEREFORE, BE IT RESOLVED that the Common Council does hereby approve the following Facade

Improvement Grant:

1. Grantee: **319 State Street, LLC dba The Soap Opera**, located at **319 State St**
2. Scope: The owner is replacing the existing storefront doors:
  - a. **Replacement of existing storefront doors with new oak doors**
  - b. **Restore and reuse existing brass hardware**
  - c. **Installation**
3. Project Cost: Total project cost is estimated at \$7,577.00. Façade Improvement Grant estimated at \$3,788.50, and shall not exceed 50% of the project cost.

BE IT FINALLY RESOLVED that the Mayor and City Clerk are authorized to execute a grant agreement with the Grantee and any other documents necessary to complete the purpose of this resolution in a form approve by the City Attorney.
