#### PREAMBLE

The City of Madison Engineering Division is proposing to conduct watershed and flood studies for the west and near west sides as a result of extreme rain events over the past several years. The City entered into an agreement with MSA Professional Services, Inc. for engineering services (RES-19-00519). The City Engineer requested additional engineering services and recommend that they be undertaken by MSA Professional Services, Inc. for the Greentree/McKenna Watershed Study as defined below:

1. Additional analysis of pre-flood mitigation conditions.
