Fiscal Note

The proposed resolution deletes the classification of Water Utility Operations Leadworker in Compensation Group 16, Range 15, recreates the classification in Compensation Group 16, Range 16, and reallocates the incumbents to the new classification in the Water Utility operating budget. The change is effective November 21, 2021. The 2022 cost is approximately \$17,000 and will be absorbed within the Water Utility's operating budget. The estimated annual cost is \$15,500.
