Creating Section 28.022-00608 of the Madison General Ordinances to change the zoning of portions of property located at 4846 Eastpark Boulevard, $17^{\text {th }}$ Alder District, from SEC (Suburban Employment Center) District to CC-T (Commercial Corridor-Transitional) District and Creating Section 28.022-0069 of the Madison General Ordinances to change the zoning of portions of property located at 4846 Eastpark Boulevard from SEC (Suburban Employment Center) District to TR-U2 (Traditional Residential - Urban 2) District.

## Body

DRAFTER'S ANALYSIS: This ordinance amendment changes the zoning of portions of property located at 4846 Eastpark Boulevard from SEC (Suburban Employment Center) District to CC-T (Commercial CorridorTransitional) District, while rezoning the rest of the parcel from SEC (Suburban Employment Center) District to TR-U2 (Traditional Residential - Urban 2), all to facilitate future mixed-use and multi-family development.

The Common Council of the City of Madison do hereby ordain as follows:

1. Map Amendment 00608 of Section 28.022 of the Madison General Ordinances is hereby created to read as follows:
