Title

Deleting Subsection (d), renumbering the subsections and creating Subsection (j) to Subdivision 6 of Section 2.05 of the Madison General Ordinances to allow direct introduction and sponsorship of certain resolutions recommended by the Personnel Board or the Director of Human Resources.

Body

DRAFTER'S ANALYSIS: Section 2.05(6) of the Madison General Ordinances provides that resolutions must be sponsored by a member of the Common Council or the Mayor or both. This ordinance allows resolutions relating to position reclassifications, position creations and deletions and the City's Deferred Compensation Plan to be directly introduced and sponsored by either the Personnel Board or the Director of Human Resources. This change is similar to the direct introduction and sponsorship of resolutions granted to the Board of Public Works in Section 2.05(6)(j).

The Common Council of the City of Madison do hereby ordain as follows:

- 1. Subsection (6) of Section 2.05 entitled "Introduction of Business" of the Madison General Ordinances is amended as follows:
- "(6) Unless otherwise provided in these ordinances, no ordinance or resolution shall be introduced unless it is sponsored by a member of the Common Council or the Mayor or both. Use of a Common Council member's name as sponsor must be with their knowledge and consent. This provision shall apply not only to ordinances and resolutions, but also to all substitutes and amendments. The provisions of this

subsection shall not apply to the following:

- (a) Recommendations of the City Attorney or Risk Manager relating to claims.
- (b) Recommendations and advice of the City Attorney relating to litigation in which the City is or is going to become involved.
- (c) Changes to ordinances and resolutions which may be mandated by state or federal law.
- (d) Recommendations of the Personnel Board relating to the classification of positions.
- (ed) Changes to ordinances and resolutions which may be required by the adoption of the annual City Budget.
- (fe) Petitions for direct legislation pursuant to the provisions of Wis. Stat. § 9.20.
- (gf) Ordinances and resolutions necessary to implement Public Works projects previously approved in the annual City Budget or allowed under Subdivision (j) of this ordinance.
- (hg) Zoning map or text amendments allowed under Sec. 28.182(2), MGO, certified survey maps, or subdivision plats to be sponsored by the Plan Commission or Planning Division.
- (<u>ih</u>) Changes to ordinances recommended by the City Attorney which are intended to correct errors, omissions or inconsistencies therein.
- (jj) Resolutions recommended by the Board of Public Works which:
 - 1. Award public works contracts,
 - 2. Accept identified public works improvements,
 - 3. Approve plans and specifications and authorize the Board of Public Works to advertise and receive bids for identified public works contracts,
 - 4. Accept identified improvements by private contracts,
 - 5. Accept identified street improvements by private contracts,
 - 6. Approve plans and specifications for public improvements for identified subdivisions.
 - 7. Authorize construction to be undertaken, and
 - 8. Authorize amendments to previously executed contracts.
- (j) Resolutions recommended by the Personnel Board or the Director of Human Resources relating to:"
 - 1. Position reclassifications
 - 2. Position creations and deletions,
 - 3. The City's Deferred Compensation Plan(s).
