ALCOHOL LICENSE REVIEW COMMITTEE

SHERI CARTER (10th A.D.) - appoint to the remainder of a three-year term to the position of Adult City Resident succeeding Stefan J. Fletcher. Sheri Carter is a former alder - having served on the City's Common Council for eight years. During her tenure, she served on numerous city committees and held the positions of common council vice president and president. She is a public servant working for the State of Wisconsin Department of Health Services and has been involved with numerous community organizations over the years.
