Fiscal Note

The proposed resolution approves plans and specifications and authorizes the Board of Public Works to advertise and receive bids for Sidewalk, Curb & Gutter, and Concrete Pavement Patches, City wide Installation and Repair - 2024. The total estimated cost of the project is \$975,000. Funding is available in Munis projects #14814 (\$525,000), #14896 (\$150,000), and #13634 (\$300,000). No additional appropriation is required.

Body

This citywide program provides for the installation of new, and the repair and replacement of existing, sidewalk, curb & gutter, concrete pavement, and concrete bus pads.
