Title

Accepting sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) constructed by Private Contract In Northeast Addition to Grandview Commons Phase 5, Private Contract No. 9092 (3rd AD).

Body

WHEREAS, the VH GVC NE, LLC, has satisfactorily completed the installation of sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) by private contract, in accordance with the City of Madison Standard Specifications for Public Works Construction, in: Northeast Addition to Grandview Commons Phase 5.

NOW, THEREFORE, BE IT RESOLVED

- 1. That said sanitary sewer, storm sewer, and street improvements (excluding bituminous surface pavement) be and are hereby accepted.
- 2. That said sanitary sewer improvements are hereby assigned to the Madison Sewer Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Sewer Utility's "Utility Plant In Service".

That said storm sewer improvements are hereby assigned to the Madison Storm Water Utility for ownership and maintenance and that the attached Schedule "A" representing the actual cost of construction of these improvements shall be reflected in the Madison Storm Water Utility's "Utility Plant In Service".

Increase in Total Plant Value per Schedule "A" \$91,507.95.

4. That the street improvements, **excluding the bituminous pavement**, on the following streets be and are hereby accepted:

- Stoney Oak Lane from the West line, Lot 1105 to Peterson Street
- Stoney Oak Lane from Peterson Street to Galileo Drive
- Peterson Street from the South line, Lot 1135 to Stoney Oak Drive
- Galileo Drive from the South line, Lot 1144 to Stoney Oak Drive
- Galileo Drive from Stoney Oak Drive to the North line, Lot 1115

The attached Schedule "A" representing the actual cost of construction of these improvements, which shall increase the street infrastructure value for Project No. 13853 \$205,972.11 for a useful life of 40 years.
