Description: Wisconsin State Statutes requires that the BID Board be composed of at least five members

and that a majority of the Board members shall either own or occupy real property in the District. If the actual property or business owner is an entity, that entity shall designate a representative to act on its behalf. The Board is responsible for the implementation of the operating plan. This requires the Board to negotiate with providers of services and materials to carry out the operating plan; to enter into various contracts; to monitor the effectiveness of the District's activities; to aid compliance with the provisions of applicable statutes and regulations; and to make reimbursements for any overpayments of District assessments.
