### Dear Madison Common Council,

On behalf of the American Family Insurance Championship and the Steve Stricker American Family Insurance Foundation, thank you for taking the time to review our request to utilize the Cherokee Marsh Park Parking Lot during week of June 2-8, 2025. We appreciate your thoughtful consideration as we work to host a safe, successful, and community-minded event in our new North Side location at TPC Wisconsin.

First, as an initial basis, the Steve Stricker American Family Insurance Foundation (a registered 501c3 charitable entity) is the host organization of this PGA TOUR Champions sanctioned event. Under the direct guidance of American Family Insurance, a 98 year-old company based in Madison, we have been successfully executing a safe event since 2016 at University Ridge Golf Course in Verona, WI. In 2025, the Foundation has a venue rental agreement with TPC Wisconsin, and will now be hosting the event at the new Madison location.

To execute this large-scale event, our team has worked closely with a number of constituents to develop a logistical and operational framework for the surround areas. While, we are happy to share appropriate information associated with the overall planning efforts, please find below an executive summary specific to our request for the temporary closure of the Cherokee Marsh Park Parking lot.

Since our initial outreach to the city in 2023, our organization has been working with the City of Madison, Madison Police Department, Madison Fire Department, Madison City Parks, Street Use, Parking Enforcement, Madison Metro, and City of Madison Traffic & Engineering to ensure a safe and welcoming environment for fans, volunteers, players, and neighbors alike. Together, we're actively developing plans to minimize disruption while prioritizing safety for all involved.

We've recently had an introductory meeting with the newly elected Madison City Alders: Alder Carmella Glenn of District 18—which encompasses the TPC Wisconsin property—and Alder Julia Matthews of District 12.

Additionally, we have been in communication with representatives of the Cherokee Park Neighborhood Association and the Cherokee Garden Condo Association to share initial plans and gather their feedback. Listening sessions for the area condo associations and neighborhoods surrounding the property are also in the process of being scheduled. Once all feedback is received, broad based communication to all residents will be shared to ensure clear and accurate information is presented.

Specific to our request for controlled access to the Cherokee Marsh Park parking lot, the event has developed a plan to use that space as a secured location for tournament operations vendors. The Cherokee Marsh Park parking lot, which is immediately adjacent to the TPC Wisconsin property, provides critical space for operations, food & beverage, and television vendors. In collaboration with Madison City Parks, plans have been developed to ensure barriers are in place that will restrict

tournament vehicular access to only the stoned portion of the lot, while protecting the surrounding native grasses.

During tournament week, vehicular access to the Cherokee Marsh Park parking lot will be closed to the public to ensure the safety of vendors and guests on property. However, pedestrian and bicycle access to Cherokee Marsh Conservation Park – North will remain open. To support this parking lot closure, alternate public access plans have been developed using Burning Wood Way. These measures help maintain public access to the park while also addressing essential security and operational needs for the event.

To ensure the safety of all guests in attendance, Sherman Avenue (north of Wheeler) access will be controlled - in partnership with the Madison Police Department - to only residents, PGA TOUR Champions officials, vendors and tournament staff. Madison Police Department officers will be stationed at the Sherman/Wheeler and Comanche intersections to ensure security and reduce non-authorized neighborhood traffic. Parking officials will be stationed along Sherman Avenue at TPC Wisconsin Cherokee Marsh Park and St. Peter Catholic Church to ensure authorized users have access to these locations.

In addition, no-parking signage will be posted along Comanche Way, Wheeler Road, and portions of Sherman Avenue. For general public, sponsor and volunteer access to the event, we are directing patrons to an offsite location at Madison College for bus shuttles to the tournament grounds (announced on March 27, 2025).

These collective plans have been developed to help ensure attendees of the tournament are not parking in the immediate areas of TPC Wisconsin property. (see attached maps)

Event plans are developing and evolving on a daily basis as feedback and permit approvals are received. These plans will be continued to be communicated via email to the neighborhood associations, alders, and presented at a listening session once approvals and/or permits are in place. Please know, all efforts are implemented with the objective to ensure a safe environment for attendees and Cherokee Marsh area community.

Since 2016, the American Family Insurance Championship has raised nearly \$20 million for charitable organizations (the Madison Parks Foundation has been an annual beneficiary) and provided over \$100 million in economic impact to the greater Madison area. We're excited to continue to grow that impact as we host the event on the North Side and build a tradition that benefits the community for years to come.



Good morning alders of Madison,

I reside in Madison, in condos just off of N. Sherman Avenue and close to Cherokee Marsh.

I'm registering as OPPOSED to allowing the Mayor and City Clerk to enter into a Parking Lot and Driveway Use Agreement with the Steve Stricker AFI Foundation to use the parking lots for the June 6-8 golf tournament.

1.) **zero communication**: As a neighbor, I've not heard ANYTHING from the Steve Stricker group /TPC about this event, until only recently, and from reading the monthly newsletter of the Friends of Cherokee Marsh. For the record, Cherokee Garden Condos have told us next to nothing as well.

The Cherokee Golf enterprise/TPC is not a good neighbor, A good neighbor would go out of their way to talk to their community about plans that would affect it. Unfortunately, there has been zero communication with us about the tournament and a host of other developments that have occurred in the last few years. TPC did, however, send condo residents a solicitation to join the newly 'improved' golf club, which indicates to me that they had the capacity to communicate with us, but chose not to. This is not ok.

2) The use of a city park as a parking lot for a private, for profit entity troubles me. Will the park be officially closed to the public during that time? Will that fairly small parking lot actually accommodate the number of cars expected?

3.) Who will enforce the parking? I understand the golf tournament is going to happen, and something needs to be done to address the traffic and cars. A neighbor told me recently that they had heard that observers would be *bussed* in to the tournament. That apparently isn't going to be happening, but we hear nothing about the logistics of what is sure to be a massive event. Again, we are in the dark. I envision people "casually" parking along the long, gravel road stretch of N. Sherman Avenue, thinking it's ok. Will golf enthusiasts park in the nearby streets? There are a myriad of issues that need to be considered.

4) Why has there been **NO city-sponsored public hearing** to give neighbors like me and countless others an opportunity to hear what is being planned, and what we can expect? The process for deciding the use by a private company of public lands/parking lot for a private event is deeply troubling.

The idea that the Common Council would authorize the Mayor and the City Clerk to enter into a Use Agreement is offensive. There should be a public engagement process. I know it's too late for that, and I don't know who is responsible for this last minute effort to get approval for TPC et. al., to use the parking is undemocratic and troubling.

Please do not authorize City execution of the current agreement for use of Cherokee Marsh parking lots and driveway for the June 6-8 golf tournament at Cherokee Country Club, a/k/a TPC (Tournament Players Club) for the following reasons:

1. Cherokee Marsh Conservation Park is just that: a conservation park, not a parking lot.

2. It appears Event planners are being given exclusive use of two parking lots and a long driveway, without limitations on how Event activities will disturb park wildlife and park visitors. Noise and disturbance (e.g. dust) from loading, unloading and staging activities are authorized for a full week (June 2 - June 8, 2025) each day from 4:00 am through 10:00 pm, well beyond the posted park closing of 1 hour after sunset.

3. The agreement is being rushed through, without community input . . . even though the tournament was announced many months ago.

4. Unless the agreement states otherwise, it sets precedent to use conservation park land for commercial activities. As a taxpayer and environmentalist, this is *not* what I expect to happen at our precious conservation properties.

Re: Resolution to enter into an Agreement for commercial use of Cherokee Marsh Conservation Park-North Unit (Agenda item 127, File 87830).

I urge you not to approve the resolution at this time. Insufficient information has been published about the intended use of the Park, there has been little opportunity for public input, and the Agreement and its enforcement appear to be insufficient to protect the Park.

The City's website states, "Conservation parks are uniquely managed with the primary purpose to preserve Madison's native landscapes, plants and animal populations for the careful use and enjoyment of visitors."

The Agreement reserves the Park's motor vehicle access (parking lots and road) during a week in June for the exclusive use of a golf tournament, apparently for support activities such as food preparation and other services. No public motor vehicle access to the park will be allowed during this time.

There has been no public discussion of why the City considers a week of commercial activities limiting public access to be consistent with the Park's "primary purpose".

The proposed Use Agreement, as published in the File, does not appear to contain reasonable safeguards to ensure that "careful use" of the Park as stipulated in the City's objective.

While the event organizer "acknowledges" the Park rules in the proposed Use Agreement (5.D), the Agreement does not commit the organizer to follow the rules, to educate its service providers about the rules, and to enforce provider compliance.

These omissions, and other ambiguities in the Agreement, raise questions about the commercial use's potential impact on the objective to "preserve Madison's native landscapes, plants and animal populations."

Despite receiving \$14,000 under the Agreement, the City has not committed to staff a comprehensive enforcement effort that would, at all times and locations, deter violations of Park rules and of the Use Agreement terms, and that would promptly deal with violations as they happen. Park rules and a Use Agreement for which it is understood in advance there will be no significant enforcement are unlikely to yield "careful use".

This is not to say that a satisfactory Agreement cannot be worked out. But it will require more

time for better communication from the Event organizers and from the City, for citizen input, and for careful public consideration of the issues.
