# Park Superintendent's Monthly Report Summary

February gave us some real winter weather that allowed a continuation of our skating season until nearly the end of the month. The snow fall provided some opportunities for sledding and skiing as well. The lack of snowfall limited the duration of the snow season, but the quality of the snow did provide some opportunity. Overall, it was a significantly better than average skating season and a below average skiing season. I think this really points to the need to offer an array of winter recreation opportunities to position our offerings in a way that is resilient and inclusive of our community.

March has started with some warm temperatures and some windy days. This really helps get the ground thawing and drying out. We don't have a date for golf and athletic fields, but we know the pressure is on and staff are doing everything they can to provide these services as soon as we can. As we move into the shoulder season we will continue to monitor dog parks, disc golf courses, golf courses, and athletic fields for playability. We strive to keep and/or get these open as quickly as we can, but as the frost comes out of the ground and it is wet, there is a period where the turf just cannot handle the impact of use. I'm proud of the team for continuing to refine these processes to promote as many opportunities as possible, but without allowing significant long-term damage to occur.

The Parks Division was well represented at the Mayor's Team City Awards on March 4, 2024. Wilkie one of our Landscape Maintenance Worker's on our Ecology Team. They were recognized for their expertise, commitment, and positive attitude in their work. The Mayor specifically noted her appreciation of Wilkie's role in planting hundreds of trees annually. An inter-agency staff team who worked on the Rennebohm Park project was also recognized at this event. The team consisting of staff from Engineering and Parks, led by Kate Kane and Charlotte Blotz on the Parks side, were able to navigate a number of challenges to make improvements to the shelter and the tennis courts while balancing multiple challenging situations. This included providing a path to keeping the Cap City Band going for their summer season.

As a reminder to the Commission, Earth Day and Arbor Day are quickly approaching. The Parks Division's Annual Earth Day Challenge is April 26<sup>th</sup>. We are hopeful to get over 900 volunteers on this day to work at over 60 park locations.

### Future Commission Items

- Pay to Park in Parks Pilot The Council rescinded the pilot program for 2025. They included a
  requirement of a report regarding parking assets in parks to be submitted by April 2026. This item will
  be removed from this list after this month, with an expected return to the Commission in late summer of
  early fall this year.
- 2025 Division Workplan The Management Team is finalizing our primary work plan items for the year and corresponding milestones. It is our hope to provide an update to the Commission in April. The work plan focuses on our significant change initiatives that have an array of impacts across our system and organization.
- Marshall Houses Parks staff continues to work with Real Estate and the City Attorney's Office to
  engage with the property owners of the historic homes in Marshall Park. At this time there has been
  limited interaction with the current owners over the past few months, so the item has been lowered on
  the priority list.
- POSP Update Parks staff is planning to provide an update on the POSP progress to the full BPC in April. LRP is working through strategies and recommendations, and a full draft plan will be available soon. The hope is to have an overview of the entire plan for BPC that has been reviewed by LRP.

• Olin Houses – Staff are working on a management plan for the Olin Houses as we acquire them. We own three of the houses at this point and would like to have a management strategy in place moving forward. The current plan on the three is working towards demolition on one home, extending the lease on a second, and evaluating options with Real Estate on the third. Over the past couple of months, we have focused energy on a potential acquisition and ensuring we are prepared for the demolition. Staff expects to be able to share a plan with the Commission over the summer.

Cooper Schira Mix was hired as Golf Course Superintendent 1, and will be working at The Glen Golf Park. Cooper began his new position February 3, 2025

### Retirements:

Mike Aeberhard has retired from his position as Park Maintenance Worker from West Parks- Forest Hill Cemetery. Mike worked the City for 21 years.

# **P&D Superintendent Report Highlights**

- Work on the POSP continues. In February the Long Range Planning Subcommittee reviewed the revised strategies. Staff continues to work on developing and refining other sections of the plan.
- Staff has been working with Veridian regarding new parkland dedication for the expansion of Midtown Commons Park and Newberry Park as a part of the Hill Valley Plat.
- Bids were received for the Rennebohm Sprayground project. Staff is recommending award of the contract to Parisi Construction for \$470,502.70. Construction is scheduled to be complete in the Summer of 2025.
- Bids were received for the installation of new Sun Shelters at Kestrel Park, Sycamore Park, and North Star Park. Staff is recommending award of the contract to Greener Valley Landscaping for \$202,195.00.
   Construction is scheduled to be complete in the Summer of 2025.
- Staff is working to prepare bidding documents for the Country Grove Park Singletrack project, Sport Court Resurfacing project, 2025 Playground Replacements project, and the Rennebohm East Tennis Courts reconstruction project.
- Schematic design for Phase 1 of the Madison LakeWay project is complete. Staff is coordinating
  improvements with City Engineering and City Forestry prior to starting the design development phase of
  the project. Construction is planned to begin in 2027.
- Staff has begun the process of preparing the Capital Improvement Plan for the 2026 budget process.

### **Community Events (Kelly Post)**

- The Community Event team has been actively enhancing applications, processes, and workflows to improve efficiency. We are prepared and excited for the 2025 Special Event season!
- We are excited to work with some new event organizers. We are committed to assisting event organizers
  navigate city regulations to host inclusive and well-coordinated public events. Some of the new events
  we will be permitting this year are:
  - Divine Mercy Festival Sunday, April 27, 2025, at James Madison Park
  - USA Cycling Collegiate National Championships Sunday, May 4, 2025, in the Tenney Lapham Neighborhood around Reynolds Park.
  - All City Swim Tuesday, July 29 Monday, August 4, 2025, at Hill Farms Pool and Rennebohm Park.

• We are gearing up for Carts in Parks 2025 – a program that supports small business owners by managing vendor permits, placements, and connections with Community/Neighborhood Park events. We are helping them thrive in public spaces.

### Parks Alive (Debra Alleyne)

### Parks Alive AASPIRE Intern

 The position description for the internship this summer has been updated better to reflect the dynamic nature of the Parks Alive program. Interview dates have been set, and panelists have been contacted to help select candidates for the summer.

#### Merchandise

• Ten Parks Alive merchandise items have been delivered to serve as community connectors and social facilitators for the events. These items include music, technology, sports, and games, all featuring the Parks Alive logo.

# **Partner Meetings**

• We are planning meetings to update our partners about the changes in the program this year. Three presentation dates have been proposed for partners to attend in March. Additionally, we are scheduling more presentations specifically for food vendors and entertainment.

# **Customer Service (Joanne Austin)**

- Watercraft storage renewal notifications were sent to current customers asking if they intend to renew
  their agreements. This proactive approach to reach out before agreements expire on March 31st
  continues to work well. Many customers have already renewed. We will contact those on our waitlist
  starting April 1st for any spaces that become available.
- Shelter reservations are well underway for 2025. 2025 shelter reservations started on November 1, 2024. Excluding large special events, Parks sponsored events, and election reservations, we have already processed 456 reservations. Of these, 284 have been placed online. The Highland Manor Storm Shelter, which is available the entire year, already has 73 reservations scheduled, most of which are on weekends. The Olin Pavilion has 31 reservations, many of which are for wedding celebrations. The New Door Creek shelter will be available for reservations this year and we already have 14 scheduled reservations. As usual, it will be an exciting shelter reservation year!
- Athletic reservations are in full swing and the QDP (Qualifying Discounts Program) is moving forward.
   Agreement holders and those with early priority reservation status have entered their reservations. Public reservations recently started requesting theirs too.
- A decent amount of snow finally arrived and cross-country ski permit holders were able to enjoy the trails this winter. As of Tuesday, February 25, we issued 329 daily ski permits this winter season and 434 annual permits, which are valid through 12/31/2025.

### **Recreation Services & Aquatics (Tracey Hartley & Shane Martin)**

### Winter Recreation

The winter season concluded on Sunday, February 16. It was our best season since 2021-2022. The
following facilities were open for skating: Elver for 48 days, Tenney for 45 days, and Vilas for 50 days.
Additionally, ski trails around the city were open for 22 days. Looking ahead to 2025-2026, Door Creek
will open with rentals for skiing, snowshoeing, and skating.

### Aquatics

Preparations for the summer season are underway. We anticipate needing to hire approximately 40 lifeguards. We are partnering with MSCR to host four hiring fairs—one at the end of March, two in April, and one in May. The beaches and splash parks will open on Saturday, May 24, and Goodman Pool will open on Thursday, June 12.

### **Rangers & Volunteers**

# Rangers (Steve Dray)

#### Recruitment

Rangers will be opening recruitment for our Seasonal Park Rangers position soon. These part-time, seasonal positions play a vital role in keeping our parks safe and accessible to our summer park users. We will also be hiring a hybrid Park Ranger/Parking Enforcement Officer position in the near future. This is a newer position that works as a Park Ranger from Mid-April through Mid-October and as a Parking Enforcement Officer from Mid-October to Mid-April, helping each agency fill an area of need.

### **Enforcement Contacts**

Rangers have had 22 enforcement contacts that resulted in 8 warnings, 14 citations and zero bans. 18 parking tickets were also issued to date during the month of February.

### Ranger Training

Madison Park Rangers attended our annual consortium meetings with Rangers from the UW Arboretum,
Dane County and the WI DNR, as well as WI DNR Conservation Wardens and Park Managers,
Madison/Dane County Animal Services Officers, and members of the Dane County Sheriff's Office Marine
and Trail Enforcement. It was a very informative time of networking and learning from each other.

# **Volunteers (John Weichelt)**

## Volunteer Management Software

• The development of the Get Connected platform is ongoing. The next steps include publishing more volunteer opportunities and testing features for tracking training and certifications. While engagement levels remain strong, we recognize that growing overall participation is an ongoing priority. We are focusing efforts on targeted recruitment for events such as Earth Day and dog park cleanup.

### Volunteer Engagement & Outreach

• We have made significant progress on the volunteer website by refining features for easier navigation and simplifying the posting of volunteer opportunities. Additionally, we have addressed communication needs related to training requirements and role expectations in the volunteer program documents.

• The exterior walls and steel framework have been established, and electrical work inside the old gym will begin on March 3.

Due to the ongoing expansion project, we will offer a smaller Family Fun Night on March 14. Additionally, the WPCRC will be hosting a Community Dinner on March 30.

# **February 2025 Monthly Update**

Comprehensive Master Plan Request for Qualifications – Olbrich Gardens is seeking a team of
planning professionals to design a comprehensive master plan. The request for qualifications is now
open for interested firms. This plan will strategically outline the growth for Olbrich Gardens over the
next 10-20 years. It closes on March 21<sup>st</sup> at 2pm.



• Collards Kick-Off Event – On February 1st, Olbrich Gardens in collaboration with REAP Food Group hosted the Collards Collaboration Kick-Off. Dr. Fabu kicked off the event with poetry readings from her latest book "We Eat to Remember: Soul Food Poetry". Qwantese Winters lead an insightful discussion with four generations of farmers, that centered on the challenges Black farmers have experienced and the ways in which everyone can support their efforts moving more forward by sharing their stories on social media, volunteering at the farms, purchasing produce grown by local farmers (while respecting the pricing) and donating funds through supporting organizations. The kick-off wrapped up with a filming screening of Farming While Black, a documentary that spotlights a rising generation of Black farmers finding strength in the deep historical knowledge of African agrarianism — and its potential to save the planet. # **Central/ Ecology Team**
