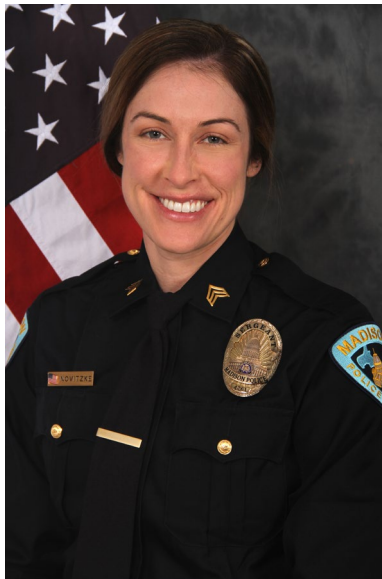
It is my pleasure to announce to the organization the following acting promotion:
