I am writing to confirm that the City of Madison Parks Division fully supports an extension of the Temporary Land Use permit until September 30, 2025. As we discussed, the Parks Division has had some significant staffing disruptions over the past few months, and we have not been able to process this permit extension at this date. I do anticipate that being completed by early February.

I know that you intend to utilize the space for events this year and our staff team will work to ensure that we assist in making sure everything is set up to succeed in doing so. Based on the information you had submitted to us last Fall, I do not foresee any significant reasons for concerns on your plans. Staff are actively reviewing this now and should we see anything of concern, we will reach out immediately in a way to ensure we help you have success.
