Dear committee members

I recognize that Dairy Drive was created as a temporary location. I also understand that it has been wildly successful at working with chronically homeless individuals who have been unwilling or unable to get necessary help in large congregate settings. With over 75% of those leaving Dairy Drive going to positive living situations, this seems like a plan that has really worked. The city/county does not have enough places to serve this population, so shutting down Dairy Drive just because it was created as a "temporary" location without an alternate solution for these people does not make sense.

It is also my understanding that there is an opportunity to continue operation thru next April without additional funding from the city. It seems like eliminating 28 or 29 spaces for individuals experiencing homelessness as cold weather is approaching is cruel and unnecessary. If Dairy Drive is closed these individuals will be less well served, harder to find because street outreach will be out looking for them instead of serving them where they are congregated.

I have heard that Dairy Drive is "expensive." The city put \$179,000 into Dairy Drive last year. That is \$6,400/person (assuming 28 residents). The new men's shelter will cost the city \$1,500,000 for 250 residents or \$6,000/person. If Dairy Drive is able to move dozens of residents from homelessness to housing that seems like a good deal for the extra \$400/year. Residents at Dairy drive have a safe place to be 24 hours a day, a key to their own space, staff to help them get their life on track. They aren't in a doorway somewhere generating police calls. I recognize the residents of the Dairy Drive camp also generate some demand for police/ambulance/CARES services, but not as much as they would if back on the streets.

In conclusion, I wholeheartedly support continuation of the Dairy Drive campground, at least thru the winter, and hope funds can be found to continue it in the mix of services in Madison long term. It is short sighted to spend money to demolish these still functional units when we don't have anywhere else for the residents to go

Hello CDBG Committee members:

I am emailing to urge you to support the continuation of the Dairy Drive campground for 4 more years. In this time when homelessness is increasing and the outlook for federal help is diminishing, we need to maintain our local resources that house and assist those without housing, and not demolish them.

Dairy Drive has already been constructed and paid for. All that is needed are the funds to operate it, which is already partially covered by a federal grant and expected funds from the county.

If 4 years is not possible, at least extend the contract with Madison Street Medicine to operate the campground through April. While Dairy Drive has a 70% success rate in placing its residents into housing, there are still people living at Dairy Drive with no where else to go. Keeping Dairy Drive open through April would be at no cost to the city (the county has pledged funds) and would give people a place to live during our coldest months.

I am writing to express my deep concern about the potential defunding and demolition of the Dairy Drive Campground. As the Clinical Director of a community mental health services agency in Madison, I have personally witnessed the impact the tiny home experiment has had on our community members. Housing First, as a model, has demonstrated significant long-term benefits and outcomes over shelter "housing" and should be adopted permanently. I also live close to the Occupy Madison location on N 3rd St., which, in my opinion, effectively integrates folks struggling with housing insecurity into our community.

In addition to this, I understand the city of Madison has recently taken issue with Madison Street Medicine's medical vending machine and food pantry. We cannot label ourselves as a progressive city while systematically dismantling the parallel systems created by community members to support each other and survive. I ask simply that you uphold the progressive values we elected you to enact or move out of the way so our community can care for itself.

Greetings CDBG members-

I sent the following email to all alders and wanted to share my thoughts with you. I support Alder Mayer's proposal, legistar 89779, agenda item #6- Extending the contract between the City of Madison and MACH Onehealth, Inc. dba Madison Street Medicine to provide those services and extend currently allocated funding through April 2026, at an additional cost of \$0 dollars from the City of Madison, and authorizes the use of up to \$100,000 of additional funds from Dane County to pay for those services.

In addition, if you vote to support extending the contract in 89779, please amend agenda item #4 89774- Authorizing the allocation of approximately \$3.5 million of combined City and Federal funds among seven non-profit agencies to support the provision of homeless services and housing resources beginning in 2026 - to add funds for Dairy Dr.

We need a more long term solution but at minimum, please add resources to help Dairy Drive through spring of 2026 and leverage potential county funding. The city funding that would be allocated for demolition and site restoration (est \$220K) could be redirected to pay for services at the campground in the short term.

Help answer the question of where unhoused people are supposed to live. Utilize the existing infrastructure at Dairy Dr until you have more answers.
