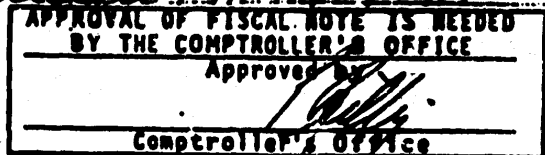

The University of Wisconsin has determined that it will build a large building (School of Business), on the block bounded by Park Street, University Avenue, Brooks Street and Johnson Street. To accommodate the activities generated by this building and others, Traffic Engineering has determined that more right-of-way is required.

The Official Map of the City of Madison is hereby amended to adding proposed highway to widen the rights-of-way of North Brooks Street, West Johnson Street, and North Park Street in Block 2, of the University Addition, a recorded plat in the Northwest 1/4 of Section 23, Town 7 North, Range 9 East, City of Madison, Dane County, Wisconsin, as shown on the attached sketch, dated July 11, 1990, and revised August 17, 1990 September 10, 1990.

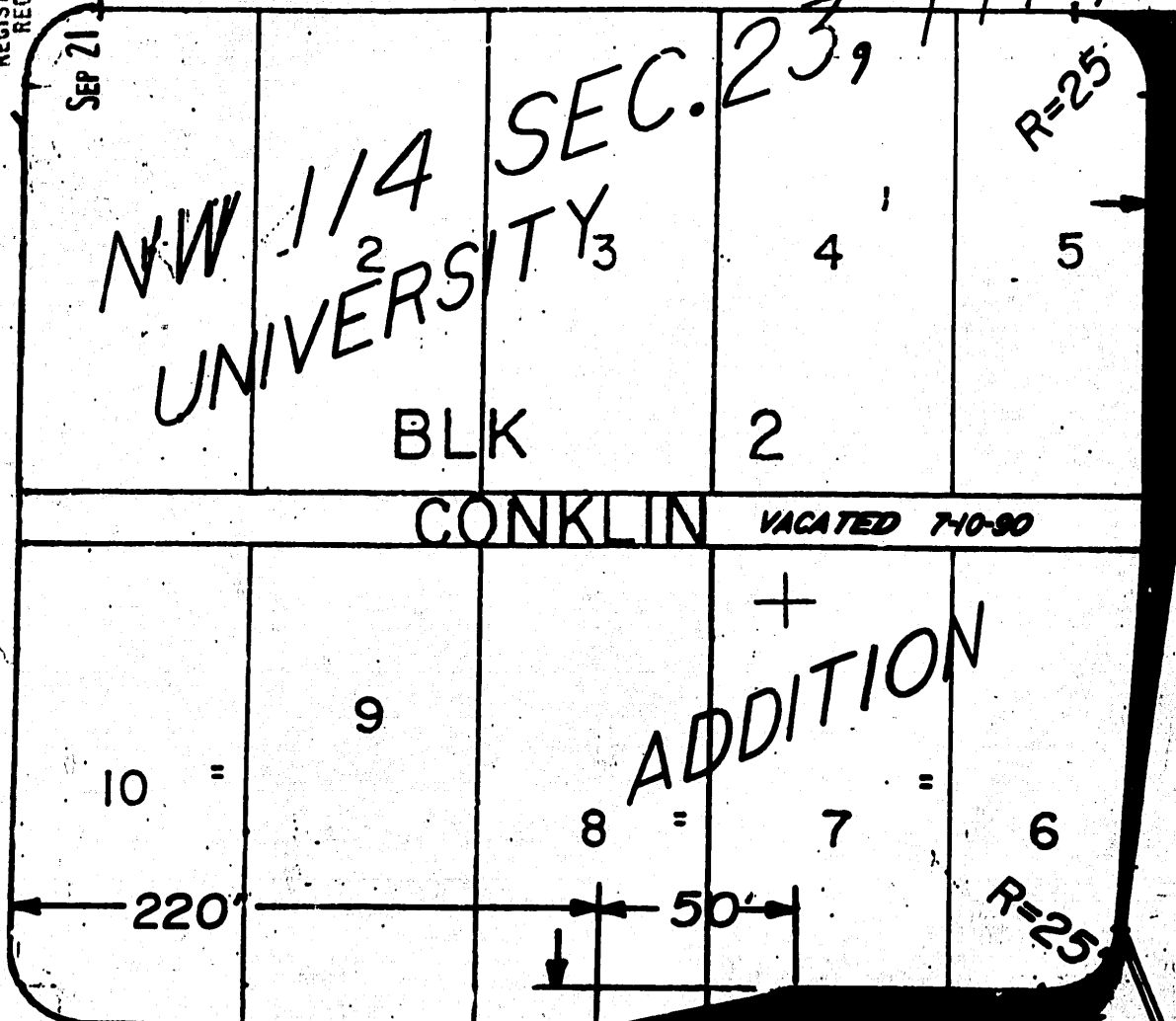
